Draft National Care Service Charter

8 What is your view of the initial draft of the National Care Service Charter?

The Charter describes the scope of the NCS as a “wide range of practical and personal support” and is quite vague in terms of the language used within the Charter. Our understanding is that the scope of the NCS is social care, social work and community health and this should be described within the Charter. For some citizens, community health and social care will include support to manage their medicines and other health treatments. In the Involvement, Participation and Choice section we suggest consideration to reflecting some of the principles of Realistic Medicine. For example, adopting some of the language when describing person-centred goals including the caring support necessary to support treatments related to health. This may include carer support for citizens to take their medicines safely and effectively. Citizens should expect that a single, consistent standard of support for the safe use and administration of medicines by carers exists in the NCS and the access to this support should be equitable across Scotland.

RPS Scotland supports the creation of a National Care Service in Scotland and agrees with the amendments made at this stage of the Bill. We want to see equity of access to high quality pharmaceutical care for every person in Scotland and it is essential that pharmacists have leadership roles in the National Care Service Board. We would see a pharmacist as part of the representation of clinicians which will form part of the Board membership.

We are pleased to see that the draft amendments mean that there will be no change to contractual arrangements for primary care services including community pharmacy.

We advocate for pharmacists to be able to read and write to the integrated health and social care record and are pleased to see that the provisions around information sharing and information standards will be applicable to both the NHS and NCS and those organisations commissioned to provide services on their behalf.

We support the policy proposals to improve workforce planning for the social work and social care workforce. Part of that workforce planning will include scoping of knowledge and skills and the RPS are particularly keen to see a nationally agreed standard to ensure safe systems for supply, storage and administration of medicines in care services by the social care workforce.
