

**Royal Pharmaceutical Society – Elections to the National
Pharmacy Boards 2024**

21 May 2024

Turnout

This year twenty one nominations were received for eight substantive places on the English Pharmacy Board (with one nomination being withdrawn before the election); therefore an election was required. In total, 17,405 ballots were issued, and 1,762 individual members voted. The turnout was therefore 10.1%.

Nine nominations were received for seven vacancies on the Welsh Pharmacy Board and an election was required for the two Community and two Any Sector vacancies. In total, 1,172 ballots were issued, and 224 individual members voted. The turnout was therefore 19.1%.

Seven nominations were received for eight vacancies on the Scottish Pharmacy Board. Therefore no election was required for the Scottish Pharmacy Board.

Voting by Channel

Voters were allowed to vote using one of two methods:

1. Over the phone – (requested candidate information by post and then called Mi-voice to cast their vote over the phone)
2. Online

In addition, an SMS was sent reminding individuals to vote online. On the day the text message was sent, Monday 20th May, 370 votes were received for the English Pharmacy Board Election, and 27 votes were received for the Welsh Pharmacy Board Election.
